A survey by Nature found that more than two-thirds of researchers experienced negative outcomes as a result of media appearances or social media comments, with 15% receiving death threats. High-profile examples include Anthony Fauci, Chris Whitty, and Christian Drosten, who all received threatening messages. The survey also revealed that 22% of respondents had received threats of physical or sexual violence, while six scientists reported being physically attacked. Coordinated social-media campaigns and threatening emails or phone calls are not new, but the abuse tied to the pandemic is a new and unwelcome phenomenon for many scientists. Harassment against scientists on the rise as they face growing scrutiny during pandemic. Researchers report emotional distress and physical threats after speaking to media or engaging online. The online abuse faced by women and people of color from marginalized groups has become a significant issue in the scientific community, particularly when discussing COVID-19 science. Experts have shared their experiences of being targeted by abusers who often resort to racist or sexist comments. Australian chief public health officer Theresa Tam was subjected to racism, while female scientist Kuppalli was told she "needs to go back where she came from". However, a recent survey found no clear difference in the proportion of violent threats received by men and women. Epidemiologist Gideon Meyerowitz-Katz noted that vaccines are often the subject of abuse, with vague death threats or hatred, while ivermectin has surprisingly received more passionate defence. suggested it showed benefits. Even the decision to delete one's account requires careful consideration. While some researchers, like Kuppalli, have taken steps to protect themselves by not responding to comments or posts when upset, others have reported more severe incidents. Trish Greenhalgh, for example, received malicious abuse from another academic, prompting her to block the abuser's followers and report the incident to their employer. Experts agree that institutions can play a crucial role in supporting scientists who face online abuse. removing researchers' contact details from institutional websites, and reporting incidents to police. Unfortunately, even when offline threats escalate, many people are not believed. However, those who report the abuse often find their employers to be supportive. According to a Nature survey, 44% of scientists who experienced online harassment never told their employer, but almost 80% of those who did found their employer to be "very" or "somewhat" supportive. In some cases, institutions have taken proactive measures to protect researchers. For instance, Tara Kirk Sell at the Johns Hopkins Center for Health Security in Baltimore received a car parking space closer to her office after informing her university about online and email attacks she had faced.
